Past-due invoices are subject to interest of 1.5% per month. Alba will apply payments on past-due invoices first against such accrued interest and second against the underlying past-due balances. Regardless of the credit arrangement between Alba and the above credit applicant ("Applicant"), Alba has the right to modify Applicant's status without prior notice. If Alba were to agree to extend credit, then Applicant agrees to pay according to the terms of this Credit Contract and Application ("Contract"). Applicant states that as of the date of this Contract, Applicant is solvent, under generally accepted accounting principles. Applicant agrees its preceding statement as to solvency is an ongoing condition to Alba's agreement to extend credit and Applicant further agrees that it shall report any material change in financial information or solvency to Alba by facsimile or e-mail within 24 hours of learning of such material change. Applicant grants Alba a security interest in Applicant's imported merchandise. Alba shall perfect its security interest in that merchandise in any way permissible under the applicable law, including by filing a UCC-1 financing statement. By signing this Contract, Applicant expressly states that it has accessed online or received, and read, understood, and accepted each set of Alba's terms and conditions of contract that may apply as to

Applicant and the services provided by Alba. Applicant understands and agrees that each set of applicable terms and conditions of contract contains a contractual limitation of Alba's liability and that Applicant shall, in each instance, have the opportunity to choose between two or more levels of liability. Applicant understands and agrees that it shall have the option under each set of applicable terms and conditions of contract to ship or store goods and to pay (A) Alba's regular/lower rates for goods with limited value and a corresponding limited liability for Alba or (B) increased rates for goods not so limited in value and a corresponding increased level of liability for Alba. Applicant agrees to reimburse Alba for freight charges it has paid, without setoff. Applicant understands and agrees that all shipments are delivered conditionally and subject to the applicable specific and general liens stated in Alba's applicable terms and conditions of contract and under law, including under California Civil Code section 3051.5. Alba has the right to sell any property of Applicant in Alba's possession or control to recover any unpaid charges as to any other property of Applicant, which understands and agrees that Alba's general lien shall survive delivery. I am an officer of Applicant with authority to sign this Contract on Applicant's behalf. I have read the Contract and I understand and agree to it. I affirm that all above information is correct and without omission of any material fact or circumstance that could bear upon Applicant's creditworthiness.
